Changes or incomplete reservations forms: To avoid any chance of confusion, any **changes** or **additions** to this reservation form **must be made in writing.** Upon receipt of your request we will send a written confirmation of the change you have requested. This will help avoid any unpleasant surprises

Terms and conditions (effective April 14, 2008)

Rooms: Prices are based on double or triple occupancy. On occasion, double rooms are not available and triple rooms are necessary with no reduction in cost. Where you need a roommate, we will make every effort to find one for you. In the unlikely event that we cannot find you a roommate, you may be required to pay the cost of a single room. We will advise you in advance if this should be the case.

Travel documents: A valid passport is required for travel.

Itineraries: Renaissance Pilgrimages Inc. reserves the right to vary the sequence of any tour should circumstances require it. Some pilgrimages require considerable walking. For those requiring wheelchairs, these must be brought with you, they are not available upon arrival. Those who require special assistance are advised that we require that you be accompanied by a qualified helper who will assume responsibility for you.

Cancellation & Refund: we strongly urge you to take out optional trip cancellation insurance. Such policies normally pay any penalties incurred if you have to cancel at the last minute due to death or illness of a traveling companion or immediate family member, reimbursement of medical expenses incurred overseas, as well as airline charges if you have to return early due to illness and many other events. There are no refunds for any unused portion of the pilgrimage. All requests for cancellations must be made in writing. The following penalties apply in case of cancellation:

Cancel over 90 days prior to departure: No cancellation fee, any airline penalties which may apply.
Cancel 60-90 days prior to departure: \$200 cancellation fee plus any airline penalties which may apply
Cancel 59-45 days prior to departure: 30% per person cancellation fee plus any airline penalties which may apply*
Cancel 44-30 days prior to departure: 50% per person cancellation fee plus any airline penalties which may apply*
Cancel 30-7 days prior to departure: 80% per person cancellation fee plus any airline penalties which may apply*
Cancel less than 7 days or no-shows: no refund.

*Airfare: once tickets have been issued they are non-refundable as specified in the ticketing agreement with the carrier.

Tour cancellation by operator: Occasionally it may be necessary to cancel a tour due to lack of participation. In such case the operator's sole responsibility is to provide a full refund. Renaissance Pilgrimages Inc. is not responsible and does not assume responsibility for any additional costs or fees relating to any other expenses. In cases where cancellation is the result of war and/or terrorism, acts of God or natural disasters Renaissance Pilgrimages Inc. is not liable for restitution.

Air Transportation: is in economy class on regularly scheduled IATA carriers such as KLM, Air France, Continental, American, Delta, etc. There is no advance seat selection for group pilgrimages, so we suggest early check-in to ensure that you can sit together with your traveling companions.

Tour prices: are in U.S. dollars based on current exchange rates as of April 14, 2008. Renaissance Pilgrimages Inc. reserves the right to adjust rates at any time and without prior notice if conditions warrant. Any revaluation or devaluation of currencies may affect published price.

Airport taxes and fuel charges: U.S. international departure taxes and foreign departure taxes are listed in each individual flier. These are based on departure city and government increases up until ticketing deadline. Airline fuel surcharges may also apply. We will invoice you separately for these taxes once we have the exact amount, which is given to us at the time of ticketing.

Baggage: We allow one checked bag weighing 50 pounds or less and a combined dimension of 62" (length+height+width). You are also allowed one carry-on with maximum dimensions of 8"x12"x20". As these requirements are constantly changing, we suggest you contact the airline for the latest information. This is enough for most pilgrimages, since people have a tendency to pack too much and later regret it. Renaissance Pilgrimages Inc. is not responsible for the loss, theft, or delay of participant's belongings.

Transfers: Our pilgrimages include ground round-trip transfers. Passengers arriving or leaving independently must transfer at their own expense.

Meals: are included according to the specific details as shown in the individual flier for your pilgrimage.

Itinerary and hotel variations: On occasion, the local tour operator may have to make last-minute changes, sometimes after arrival, of the itinerary or hotel arrangements. Therefore, we reserve the right to substitute hotels or other services at no cost adjustment.

Responsibility clause: Renaissance Pilgrimages Inc. acts as a tour operator. The suppliers providing transportation, sightseeing arrangements, and hotel accommodations for the tour programs are independent contractors and are not agents or employees of Renaissance Pilgrimages. All coupons, receipts, and tickets are issued subject to the terms and conditions specified by the suppliers. By utilizing the service of the suppliers, you agree that Renaissance Pilgrimages will not be liable for any accident, loss, injury, or damage to you or those traveling with you in connection with any accommodations, transportation or any other services resulting directly or indirectly from any occurrences or conditions beyond its control including: defects in vehicles, breakdown in equipment, thefts, delay or cancellation of or changes in itinerary for any act, omission or event during the time you are on the vehicle or aircraft. Neither Renaissance Pilgrimages Inc. and/or agents of the airlines concerned are to be held responsible for the late arrival of passengers at airports or lodging due to inclement weather, nor are they to be held liable for payment or any refund for unused hotel accommodations or meals occasioned by such late arrivals at the hotels holding rooms as confirmed itineraries. Any litigation concerning the trip, including transportation and lodging booked through Renaissance Pilgrimages Inc., may be brought only in the state of Texas and nowhere else, and Texas law will apply to any such litigation.
