

## **Interterm 2019: Exploring Spanish Business and Culture**

**Travel Dates: January 6-18, 2019**

**3 credit hours**

The crossroad of civilizations and empires endows 21st Century Spain with a rich cultural legacy but many questions of identity. Art, architecture, religion, food, sports, and regional variety will form the backdrop for our exploration. Prepare to fall in love with another country during this twelve-day experience. ¡Viva España!

The focus of this experience is on building awareness and understanding of the contemporary Spanish identity, with an emphasis on the historical contexts that have brought Spain to its current sense of identity. This will be achieved through work completed prior to departure for Spain in addition to the experiences gained while “in country” for twelve days. Contemporary Spanish identity is complex, even more so for foreigners. Among the dimensions to be explored in the proposed course are: culture, regionalism, history, religion, language, food, gender, sports, immigration, European integration, and diaspora.

The framework used to provide students with exposure to Spain’s history will include a focus on five aspects of Spain’s history: pre-history through middle ages, the legacy of the three cultures (Christian, Muslim, and Jewish), the Reconquista and Imperial Spain, the Republic and the Franco era, and the most recent era of democracy, regionalism, and membership in the European Union. Students will select from among several resources for a final report and presentation, including those found on the internet and within our library’s on-ground and online resources. A Moodle site will be developed to aid students’ access to these resources.

**Pre-departure: One half-day class meeting (timing TBD), plus 2-3 online assignments (through Moodle)**

### **TENTATIVE ITINERARY**

#### **KANSAS CITY - MADRID**

**Days 1-2 – Sunday-Monday, January 6-7 (domingo-lunes, 6-7 enero)** Group flight with Delta Airlines from Kansas City to Madrid via Atlanta; depart KCI 10:00 a.m., arrive Madrid 8:30 a.m. (following day). Four-night stay in Madrid at a 3-star hotel (Vincci Via Hotel 66; includes breakfast every morning).



#### **MADRID**

**Days 2-6 – Monday-Friday, January 7-11 (lunes-viernes, 7-11 enero)** A four-day transportation pass will be provided upon arrival. Welcome Dinner at a nearby restaurant will be arranged for Wednesday, January 10. Visit in Madrid will include: four-hour private motorcoach charter for introductory tour of the city (along with a private guide), tickets to Prado Museum and Royal Palace (self-guided), round-trip train to Toledo, entrance to the Catedral de Toledo, and one corporate visit to a local company in Madrid (some options under consideration: Movistar, Geeksphone, and Banco Santander).

## VALENCIA

**Days 6-8 – Friday-Sunday, January 11-13 (viernes-domingo, 11-13 enero)** Private motorcoach transfer arranged from Madrid to Valencia (approximately 3.5 hours) for a two-night stay at a 3-star hotel (Checkin Hotel; includes breakfast every morning). While in Valencia, we will have a guided tour of the Valencia Oceanographic Aquarium and Marine Park. We will also arrange tickets for a show at the Palau de la Musica.



## BARCELONA

**Days 8-13 – Sunday-Friday, January 12-18 (domingo-viernes, 12-18 enero)** Train from Valencia to Barcelona (approximately 3.5 hours) for a five-night stay at a 3-star hotel (Soho Hotel; includes breakfast every morning). Students will receive a five-day transportation pass. The group will be met by a local guide for a tour of Barcelona, including entrance to Parc Guell and Mont Juic Hill. Students will receive tickets to the Sagrada Familia for a self-guided visit. We will also arrange for two corporate visits in Barcelona (some options under consideration: FC Barcelona Camp Nou Stadium, Port of Barcelona, and Kantox). Farewell Dinner at a local restaurant for the final night.

**Day 13 – Friday, January 18 (viernes, 18 enero)** Group flight with Delta Airlines from Barcelona to Kansas City via Amsterdam and Dallas; depart BCN 11:10 a.m., arrive MCI 8:59 p.m.

#### Escrow Protection.

Pursuant to its registration under the California Sellers of Travel Law (CST# 2093740-40), Tour Resource Consultants LLC (“TRC”) has voluntarily chosen to deposit 100% of all credit card payments received from you via our website or checks received from your study-abroad program or tour directly into a Trust Account. This means that such funds will be separate and apart from the operating funds of Tour Resource Consultants LLC. Tour Resource Consultants LLC has also agreed to allow an independent Certified Public Accountant to review its financial receipts records for various dates randomly selected by the CPA during the prior year to verify its compliance with this procedure.

#### How Deposits/Payments received are Protected.

When TRC receives your funds through this website, they are automatically deposited into a Trust Account. If Tour Resource Consultants LLC is providing air transportation on a scheduled air carrier as a part of the tour package, TRC will pay the air carrier for your ticket in advance of your scheduled departure date. In addition, TRC will pre-pay all hotels, meals, land transportation and/or providers of travel services and other components of your study-abroad program or tour insofar as it is feasible and practical. Only after all such expenses for the program or tour are paid will the remaining funds be transferred to the regular funds of Tour Resource Consultants LLC.

#### What is not protected:

The Trust Account maintained by TRC does not protect you or any provider of travel services from loss (monetary or otherwise) resulting from the following:

- Your cancellation or interruption of your trip for any reason including death, injury, illness of you or a family member.
