Omicron was one of only 4 chapters in the nation to receive this designation including much larger chapters at M.I.T. and Florida State University. ### Balanced Budget Forecast for **Baker**:

President Long in her "State of the University Address" to faculty, staff and Administration members in mid-August indicated that the University has presented a balanced budget for the forthcoming fiscal year (2009-2010) to the University's Board of Trustees. The total budget exceeds \$35 million but is down significantly from the budget that was initially cast for the year 2008-2009 by nearly \$7 million.

The University is confident that with steady to slightly increased enrollments across all four schools, through better processes being implemented to oversee expenditures and through success in fundraising that we will meet the budget constraints and have a reasonable excess of revenues over expenditures at the end of the year—a sign of any sound business enterprise!

As a critical component of this budget, the University's **Annual Fund** was established at a level of \$605,000...a figure that Vice President for Advancement, Lyn Lakin feels can be achieved. She went on to say that though it will take consistent hard work from the development staff, she has every confidence that the continuing love and support of **Baker's** generous former students, alumni, friends and donors will pull us through to our goal.

I personally hope those of you who give every year will not only continue to give, but where possible will make an increase in your donation! For those who for one reason or another have not given in the past, I invite you to reconsider a gift this year!

### President Long Begins her "Senior" Year...

It doesn't seem possible that over 3 years ago the **Baker** community welcomed Dr. Patricia Long as our 28th President. In truth, however, that is the case and Dr. Pat is now beginning her "Senior" year. The Question was:

Building on the trivia question in May we have another Building question...on the Baldwin City Campus, there is an academic building that is on the Historic Registry of Buildings bearing the name— CASE HALL. For whom is it named and what was the building's original purpose for being built? For extra credit, in what year was the construction of the building completed and the building occupied??

**The Answers:** Chair of the Board of Trustee, NELSON CASE lead a fund raising challenge for a new library in 1898. The corner stone was laid in 1904 and the building was completed and occupied in 1907 and was named in his honor. Many years ago now, the building was placed on the U.S. Historic Registry.

## Federal Income Tax Charitable Deductions

Most everyone realizes that the federal government has provide for Income Tax Deductions for individuals and Corporate entities who make qualified gifts to charity. There are, however some limitations on the process of which you should be aware.

Some of these limitations have to do with the charities' designation as either a 50% charity or as a 30% Charity.

A 50% charity typically includes churches, educational institutions (like **Baker**), hospitals, governmental units, organizations that receive substantial support from governmental units or the general public, and certain private foundations (operating foundations, distributing foundations and pooled fund foundations described in I.R.C. 170(6)(1)(d).

A 30% charity includes other organizations (mostly private foundations) described in I.R.S. pamphlet 170C.

### Ceiling on Charitable Deductions

#### Individual Donor/50% Charity:

Total deductions are limited to 50% of the donor's adjusted gross income with 5-year carryover. Gifts of trust income to a 50% charity are deductible up to 30% AGI with a 5-year carryover.

#### Individual Donor/30% Charity:

Total deductions are limited to 30% of donor's adjusted gross income, with a 5-year carryover.

#### Corporate Donor/50% Charity:

Deductions are limited to 10% of taxable income with a 5-year carryover.

#### Corporate Donor/30% Charity:

The deduction is the same as for a 50% Charity.

As there are numerous limitations based upon the type of property contributed to charity it is best to obtain publications direct from the I.R.S. that spell these out in detail or check with a Certified Public Accountant.
