Affidavit of Financial Support for International Students

U.S. government regulations require international students to show that they have financial resources to pay for their first year of estimated expenses while studying in the U.S. A completed Affidavit of Financial Support, along with documentation of funding, are required before the I-20 can be issued.

Please submit the following documents:

1. Affidavit of Financial Support, fully completed and signed.
2. Documentation to show that the sponsor(s) can provide funding for total estimated expenses for 1 year of study, minus any renewable scholarships. One or more of the following documents can be submitted:
 - a. A bank statement from checking, savings, deposit, or current accounts, showing the name of the sponsor and current balance.
 - b. A bank letter, on bank letterhead, showing the date the account opened, average balance, and current balance.
 - c. A letter from the sponsor's employer stating income and length of employment
 - d. Scholarship or sponsorship letter verifying the amount, sources, and dates of award, and the approved program of study

Bank documents are required to:

1. Be translated into English
2. Be less than 12 months old
3. Include the type of currency
4. Include the account holder's full name

Students may have more than one sponsor. Each sponsor should complete an Affidavit and submit with financial documentation. The sponsor signing the Affidavit must be the account holder identified on the financial documents.

All forms and financial documentation should be scanned as .pdf documents and sent to anna.mccullough@bakerU.edu.
